Be it enacted by the People of the State of Maine as follows:

6 7 8 9	A person commits a traffic infraction for which a fine of not more than \$500 may be adjudged if that person operates or is a passenger on or in a sidecar attached to a motorcycle on a public way without wearing a helmet in violation of section 2062, subsection 8.
10	SUMMARY
11 12 13	Current law requires persons under 18 years of age to wear a helmet when operating a motorcycle or riding as a passenger on a motorcycle as well as persons operating under a learner's permit or within one year of completing a driving test and any passengers.
14 15	This bill requires all operators and passengers of motorcycles on public ways to wear protective helmets.
16	This bill also corrects cross-references.
