2 Committee Amendment "A" allows dental hygienists, dental hygienists with public health supervision status, independent practice dental hygienists and dental hygiene 3 therapists to prescribe, dispense or administer fluoride dentifrice and antibacterial rinse. 4 This amendment requires the prescription, dispensation or administration of these 5 substances to occur under protocols developed by the Board of Dental Examiners and 6 requires a dental hygienist, dental hygienist with public health supervision status, 7 independent practice dental hygienist or dental hygiene therapist to have a written 8 agreement with a licensed dentist in order to prescribe, dispense or administer these 9 10 substances.
