17 18	Whereas, the enactment of a new probate code in July 2019 made a change in the procedures for opening a multiple-party account; and
19 20 21 22 23	Whereas, the following legislation clarifies a provision in the Maine Revised Statutes Title 9-B requiring financial institutions to affirm when a multiple-party account is established or a single account is converted whether the party establishing or converting the account intends for any sum remaining in the account upon death to belong to the surviving party; and
24 25 26	<b>Whereas,</b> this change must be enacted before the expiration of the 90-day period to allow financial institutions to establish procedures for opening multiple-party accounts to immediately help combat elder financial abuse; and
