20 21 22 23 24 25 26 27	This amendment is the minority report and allows a person who is not otherwise prohibited from possessing a handgun to carry a concealed handgun without a permit. It also allows the Chief of the State Police to enter into reciprocity agreements with another state to permit a person holding a Maine concealed handgun permit to carry a concealed handgun in the other state. This amendment requires a nonresident to have a valid concealed handgun permit in that person's state of residence before that person is eligible for a Maine concealed handgun permit unless that person's state of residence does not require a permit to carry a concealed handgun.
