An Act To Adjust Maine's Minimum Wage Annually Based on Cost-of-living Changes

1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 26 MRSA §664, sub-§1, as amended by PL 2007, c. 640, §4, is further
amended to read:

4 1. Minimum wage. The minimum hourly wage is \$6.50 per hour. Starting October 5 1, 2006, the minimum hourly wage is \$6.75 per hour. Starting October 1, 2007, the minimum hourly wage is \$7.00 per hour. Starting October 1, 2008, the minimum hourly 6 wage is \$7.25 per hour. Starting October 1, 2009, the minimum hourly wage is \$7.50 per 7 8 hour. Starting October 1, 2013, the minimum hourly wage is \$8.50 per hour. Starting October 1, 2014 and each October 1st thereafter, if there is an increase in the Consumer 9 10 Price Index on June 30th of that year from the Consumer Price Index on June 30th of the preceding year, the minimum hourly wage in effect at that time must be increased by the 11 same percentage as the Consumer Price Index increase. For purposes of this subsection, 12 "Consumer Price Index" means the Consumer Price Index for Urban Wage Earners and 13 14 Clerical Workers, CPI-W, for the Northeast Region, or successor index, as published by the United States Department of Labor, Bureau of Labor Statistics. If the highest federal 15 minimum wage is increased in excess of the minimum wage in effect under this section, 16 17 the minimum wage under this section is increased to the same amount, effective on the 18 same date as the increase in the federal minimum wage, but in no case may the minimum 19 wage exceed the minimum wage otherwise in effect under this section by more than \$1 20 per hour.

SUMMARY

This bill raises the minimum wage to \$8.50 per hour beginning October 1, 2013, and it requires the minimum hourly wage to be adjusted for inflation on October 1st of each year, beginning October 1, 2014.
