An employee of the Department of Education, appointed by the Commissioner of 8 Education; and be it further' 9 Amend the resolve by striking out all of section 5 and inserting the following: 10 'Sec. 5. Duties; authorized meetings. Resolved: That the task force shall address the rising cost of special education and the maintenance of high-quality services 11 that accommodate the needs of all children by identifying cost drivers and recommending 12 13 innovative approaches to serving students. The task force may hold no more than 5 14 meetings; and be it further' Amend the resolve by striking out all of section 7 and inserting the following: 15 'Sec. 7. Report. Resolved: That, no later than December 6, 2017, the task force 16 shall submit a report that includes its findings and recommendations, including suggested 17 legislation, for presentation to the Joint Standing Committee on Education and Cultural 18 Affairs. The Joint Standing Committee on Education and Cultural Affairs may submit a 19 bill to the Second Regular Session of the 128th Legislature.' 20 21 **SUMMARY** 22 This amendment adds 4 members to the task force, increasing its membership to 13 members, and authorizes the task force to hold up to 5 meetings.
