18 19 20	B. Is not disqualified to possess a firearm pursuant to Title 15, section 393, is not disqualified as a permit holder under that same section and is not disqualified to possess a firearm based on federal law as a result of a criminal conviction;
21	D. Submits an application that contains the following:
22	(1) Full name;
23	(2) Full current address and addresses for the prior 5 years;
24 25	(3) The date and place of birth, height, weight, color of eyes, color of hair, sex and race;
26 27 28 29 30 31	(4) A record of previous issuances of, refusals to issue and revocations of a permit to carry concealed firearms, handguns or other concealed weapons by any issuing authority in the State or any other jurisdiction. The record of previous refusals alone does not constitute cause for refusal and the record of previous revocations alone constitutes cause for refusal only as provided in section 2005; and

33	(a) Are you less than 18 years of age?

19 20 21	(t) Have you been adjudicated to be an incapacitated person pursuant to Title 18-A, Article 5, Parts 3 and 4 and not had that designation removed by an order under Title 18-A, section 5-307, subsection (b)?
22 23	(u) Have you been dishonorably discharged from the military forces within the past 5 years?
24	(v) Are you an illegal alien?
25 26	(w) Have you been convicted in a Maine court of a violation of Title 17-A, section 1057 within the past 5 years?
27 28 29	(x) Have you been adjudicated in a Maine court within the past 5 years as having committed a juvenile offense involving conduct that, if committed by an adult, would be a violation of Title 17-A, section 1057?
30 31 32	(y) To your knowledge, have you been the subject of an investigation by any law enforcement agency within the past 5 years regarding the alleged abuse by you of family or household members?
33 34 35 36	(z) Have you been convicted in any jurisdiction within the past 5 years of 3 or more crimes punishable by a term of imprisonment of less than one year or of crimes classified under the laws of a state as a misdemeanor and punishable by a term of imprisonment of 2 years or less?
37	(aa) Have you been adjudicated in any jurisdiction within the past 5 years to

17 18 19 20 21	(1) At the request of the issuing authority, takes whatever action is required by law to allow the issuing authority to obtain from the Department of Health and Human Services, limited to records of patient committals to Riverview Psychiatric Center and Dorothea Dix Psychiatric Center, the courts, law enforcement agencies and the military information relevant to the following:
22 23	(a) The ascertainment of whether the information supplied on the application or any documents made a part of the application is true and correct;
24 25	(b) The ascertainment of whether each of the additional requirements of this section has been met; and
26	(c) Section 2005;
27 28 29	(2) If a photograph is an integral part of the permit to carry concealed handguns adopted by an the issuing authority, submits to being photographed for that purpose;

34 35 36 37 38 39	(a) Resident of a municipality or unorganized territory, \$35 for an original application and \$20 for a renewal, except that a person who paid \$60 for a concealed firearms permit or renewal during 1991 or 1992 is entitled to a credit toward renewal fees in an amount equal to \$30 for a person who paid \$60 for an original application and \$45 for a person who paid \$60 for a permit renewal. The credit is valid until fully utilized; and

A course completion certificate or other document, or a photocopy, is sufficient if it recites or otherwise demonstrates that the course meets all of the requirements of this subparagraph.
13 14 15 16 17	As an alternative way of fully satisfying this requirement, an applicant may personally demonstrate knowledge of handgun safety to an the issuing authority, if the issuing authority is willing to evaluate an applicant's personal demonstration of such knowledge. The issuing authority is not required to offer this 2nd option.
18 19 20 21 22	The demonstration of knowledge of handgun safety to the issuing authority may not be required of any applicant who holds a valid state permit to carry a concealed firearm as of April 15, 1990 or of any applicant who was or is in any of the Armed Forces of the United States and has received at least basic firearms training.
