1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 17-A MRSA §2, sub-§9-A** is enacted to read:

3 9-A. "Domestic partner" means one of 2 unmarried adults who are domiciled
4 together under a long-term arrangement that evidences a commitment to remain
5 responsible indefinitely for each other's welfare.

6 **Sec. 2. 17-A MRSA §253, sub-§2, ¶¶K and L**, as enacted by PL 2011, c. 423,
7 §3, are amended to read:

8 K. The actor owns, operates or is an employee of an organization, program or
9 residence that is operated, administered, licensed or funded by the Department of

SUMMARY

This bill makes it unlawful for a member of the clergy who is in a position of trust or authority over another person to use that clergyperson's position of trust or authority to engage in a sexual act, sexual contact or sexual touching with the other person. The bill amends the laws on the crimes of gross sexual assault, unlawful sexual contact and unlawful sexual touching.
