waivers or submit any state plan amendments to the United States Department of Health

22, section 3174-CCC.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

9 This amendment, which is the minority report, replaces the bill. It directs the Department of Health and Human Services to provide nonemergency medical 10 transportation for a parent or guardian of a MaineCare member under 18 years of age 11 who is in a residential care facility or receiving inpatient medical services if certain 12 conditions are met: the transportation is to the facility where the MaineCare member 13 under 18 years of age is receiving medical services, the presence of the parent or guardian 14 at the facility is part of the treatment plan for that MaineCare member and the costs of the 15 transportation are eligible for matching federal funds under the federal Medicaid 16 program. The amendment directs the Department of Health and Human Services to 17 submit any necessary Medicaid waivers or state plan amendments to the United States 18 Department of Health and Human Services, Centers for Medicare and Medicaid Services 19 no later than January 1, 2020 to receive federal matching Medicaid funds for 20 nonemergency medical transportation. 21
