RESOLUTION, Proposing an Amendment to the Constitution of Maine To Establish the Right To Hunt and Fish

Resolved:** Two thirds of each branch of the 2 Legislature concurring, that the following amendment to the Constitution of Maine be 3 proposed:

4 **Constitution, Art. IX, §26** is enacted to read:

15

5 Section 26. Personal right to hunt, fish and harvest wildlife; limitations. The freedom to hunt, fish and harvest wildlife traditionally taken by hunters and anglers 6 is a valued natural heritage that must be forever preserved for the citizens of this State. 7 Every citizen has the personal right to hunt, fish and harvest wildlife, using traditional 8 methods, subject only to statutes enacted by the Legislature and to rules adopted by the 9 10 designated state agency to promote wildlife conservation and management and to preserve the future of hunting and fishing. Public hunting and fishing are a preferred 11 12 means of managing and controlling wildlife. This section may not be construed to modify any provision of law relating to trespass, property rights or the regulation of 13 commercial activities. 14

16 **Constitutional referendum procedure; form of question; effective date.** 17 **Resolved:** That the municipal officers of this State shall notify the inhabitants of their 18 respective cities, towns and plantations to meet, in the manner prescribed by law for 19 holding a statewide election, at a statewide election held in the month of November 20 following the passage of this resolution, to vote upon the ratification of the amendment 21 proposed in this resolution by voting upon the following question:

"Do you favor amending the Constitution of Maine to provide that the
citizens of Maine have the personal right to hunt, fish and harvest
wildlife, subject to laws and rules that promote wildlife conservation and
preserve the future of hunting and fishing, and to provide that public
hunting and fishing are a preferred means of managing and controlling
wildlife?"

28 The legal voters of each city, town and plantation shall vote by ballot on this question 29 and designate their choice by a cross or check mark placed within the corresponding square below the word "Yes" or "No." The ballots must be received, sorted, counted and 30 31 declared in open ward, town and plantation meetings and returns made to the Secretary of 32 State in the same manner as votes for members of the Legislature. The Governor shall review the returns. If it appears that a majority of the legal votes are cast in favor of the 33 34 amendment, the Governor shall proclaim that fact without delay and the amendment 35 becomes part of the Constitution of Maine on the date of the proclamation; and be it 36 further

37 Secretary of State shall prepare ballots. Resolved: That the Secretary of State
 38 shall prepare and furnish to each city, town and plantation all ballots, returns and copies
 39 of this resolution necessary to carry out the purposes of this referendum.

1 **SUMMARY** 2 This resolution proposes to amend the Constitution of Maine to provide that the 3 citizens of Maine have the personal right to hunt, fish and harvest wildlife, subject to laws 4 and rules that promote wildlife conservation and preserve the future of hunting and 5 fishing, and to provide that public hunting and fishing are a preferred means of managing 6 and controlling wildlife.
