1 SUMMARY

This amendment, which is the majority report of the Joint Standing Committee on Labor, Commerce, Research and Economic Development, eliminates the \$100,000 funding in the bill for the Industry Partnership Assistance Collaborative and instead adds it to the appropriation for the Maine Community College System's Maine Quality Centers for a total of \$1,000,000 in each year of the fiscal biennium. The Maine Quality Centers appropriation is consolidated to include use both for tuition assistance for individuals participating in workforce training and to match funding and contributions from participating businesses.

The amendment directs the Board of Trustees of the Maine Community College System to adopt necessary policies and procedures for the Maine Quality Centers, including consideration of at least 5 specific factors. It also requires program participants to use existing financial aid resources available through their sponsoring postsecondary education institution before using program resources, which may be used only for unmet expenses for tuition, fees or books.

Additionally, the amendment requires participating employers under the Put ME to Work Program to hire successful trainees at a rate at least \$2.50 per hour more than the minimum hourly wage rate as set in Maine statute and to pay incumbent worker trainees an hourly wage that meets or exceeds the median wage for that occupation as identified by the Center for Workforce Research and Information within the Department of Labor.

The amendment eliminates the provision of the bill that allows employers to make voluntary donations to the Competitive Skills Scholarship Fund.
