An Act To Better Serve the Seasonal Tourist Market during the 2015 Summer Season and Early Autumn with a Pilot Program To Extend the Authorized Hours during Which Liquor May Be Served

- 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and
- 3 **Whereas,** most tourism in Maine occurs between Memorial Day and Labor Day 4 each year; and
- 5 **Whereas,** tourists who visited Maine in 2014 when surveyed cited food and 6 beverage options as among the highest areas of interest; and
- Whereas, overnight visitors had median expenditures of \$200 per party for food and
 beverages in 2014; and

9 Whereas, tourists from Massachusetts and New York represented approximately 10 40% of overnight visitors to Maine in 2014 and both of those states allow alcoholic 11 beverages to be served on the premises until 2 a.m. and 4 a.m., respectively; and

- 12 Whereas, Maine's hospitality industry loses opportunities to cater to out-of-state 13 customers accustomed to longer hours of on-premises liquor service and this loss results 14 in fewer sales; and
- 15 **Whereas,** this legislation must take effect before the expiration of the 90-day period 16 in order for it to be in effect during the summer tourist season; and

Whereas, in the judgment of the Legislature, these facts create an emergency within
the meaning of the Constitution of Maine and require the following legislation as
immediately necessary for the preservation of the public peace, health and safety; now,
therefore,

21 Be it enacted by the People of the State of Maine as follows:

- 22 Sec. 1. 28-A MRSA §4, sub-§1, as amended by PL 2015, c. 74, §1, is further 23 amended to read:
- Hours for sale of liquor. Except as provided in paragraphs B and D to E,
 licensees may sell or deliver liquor from 5 a.m. on any day until 1 a.m. of the following
 day.
- B. Licensees may sell liquor on January 1st of any year from 12 midnight to 2 a.m.
- (1) In areas in which liquor may be sold except on Sundays, if January 1st falls
 on a Monday, licensees may sell or deliver liquor between 9 p.m. Sunday,
 December 31st and 2 a.m. January 1st, notwithstanding any local option
 decisions to the contrary.
- 32 D. Wholesale licensees may sell or deliver liquor to licensed establishments from 4
 33 a.m. on any day until 1 a.m. the following day.
- 34 <u>E. On-premises retail licensees may sell liquor from 5 a.m. to 2 a.m. the following</u>
 35 <u>day, notwithstanding any local option decisions to the contrary.</u>
- 36 <u>This paragraph is repealed October 12, 2015.</u>

- 1 Sec. 2. 28-A MRSA §4, sub-§2, as amended by PL 1993, c. 730, §14, is further 2 amended to read:
- Consumption and possession of liquor. Except as <u>otherwise</u> provided in
 paragraphs A and B this subsection, licensees may not permit the consumption or
 possession of liquor on their premises after 1:15 a.m.
- 6 A. Licensees may permit the consumption of liquor on their premises until 2:15 a.m. 7 on January 1st.
- 8 <u>A-1. Notwithstanding paragraph A, on-premises retail licensees may permit the</u> 9 <u>consumption of liquor on their premises until 2:15 a.m., notwithstanding any local</u> 10 <u>option decisions to the contrary.</u>
- 11 This paragraph is repealed October 12, 2015.

B. This subsection does not apply to consumption or possession by bona fide hotelguests in their rooms.

14 Sec. 3. Bureau of Alcoholic Beverages and Lottery Operations pilot 15 program; report. The Director of the Bureau of Alcoholic Beverages and Lottery Operations within the Department of Administrative and Financial Services shall 16 17 implement a pilot program extending the hours for the sale of liquor for on-premises 18 consumption from 1 a.m. to 2 a.m. pursuant to the Maine Revised Statutes, Title 28-A, section 4, subsections 1 and 2. The pilot program under this section terminates October 19 20 12, 2015. The director shall submit a report to the Joint Standing Committee on Veterans 21 and Legal Affairs by January 31, 2016 on the operation of the pilot program. The joint standing committee may report out a bill based on the director's report to the Second 22 23 Regular Session of the 127th Legislature.

24 **Emergency clause.** In view of the emergency cited in the preamble, this 25 legislation takes effect when approved.

SUMMARY

This bill establishes a pilot program that terminates October 12, 2015, Columbus Day, to extend the hours for the sale of liquor for on-premises consumption from 1 a.m. to 2 a.m.
