A municipality may not:

2	This amendment provides that a registered caregiver may operate one retail store to
3	sell harvested marijuana to qualifying patients. It provides that a municipality may not
4	prohibit registered caregiver retail stores, registered dispensaries, marijuana testing
5	facilities and manufacturing facilities that are operating with municipal approval in the
6	municipality prior to the effective date of this legislation and that a municipality may not
7	authorize registered caregiver retail stores, registered dispensaries, marijuana testing
8	facilities and manufacturing facilities that are not operating on the effective date of this
9	legislation to operate in the municipality unless the municipal legislative body has voted
10	to adopt or amend an ordinance or approve a warrant article allowing registered caregiver
11	retail stores, registered dispensaries, marijuana testing facilities or manufacturing
12	facilities to operate within the municipality.
