1	SUMMARY
2	This amendment is the minority report of the Joint Standing Committee on Judiciary
3	It replaces the bill to give a patient's adult child and parent higher priority than a
4	nonspousal partner to serve as a surrogate decision maker for medical decisions when the
5	patient is unable to make or communicate decisions. The bill also allows an adult sibling
5	a higher priority than a nonspousal partner.
