COMMITTEE AMENDMENT “ ” to H.P. 1132, L.D. 1528, “Resolve, Directing the Department of Health and Human Services To Adjust Reimbursement Rates for Certain Home-based Services”

Amend the resolve by striking out everything after the title and inserting the following:

'Sec. 1. Department of Health and Human Services to increase reimbursement rates for home-based services. Resolved: That, by January 15, 2022, the Department of Health and Human Services shall increase the hourly reimbursement rates for home-based services:

- 1. By 25% for registered nurse and licensed practical nurse services provided under the waiver services provisions of rule Chapter 101: MaineCare Benefits Manual, Chapters II and III, Section 19;
- 2. By 25% for registered nurse, licensed practical nurse and independent registered nurse services provided under the provisions of rule Chapter 101: MaineCare Benefits Manual, Chapters II and III, Section 96; and
- 3. By 25% for registered nurse, licensed practical nurse and independent registered nurse services provided under the provisions of rule Chapter 5: Office of Aging and Disability Services Policy Manual, Section 63.

The Department of Health and Human Services shall apply an annual cost-of-living increase in accordance with the United States Department of Labor, Bureau of Labor Statistics, Consumer Price Index for each rate in this section. Rules adopted pursuant to this section are routine technical rules as defined in the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A.

Sec. 2. Department of Health and Human Services to index reimbursement rates for certain home-based services. Resolved: That, by January 15, 2022, the Department of Health and Human Services shall index the reimbursement rates for home-based services provided under rule Chapter 101: MaineCare Benefits Manual, Chapters II and III, Section 40 to the low-utilization payment adjustment rate in accordance with 42

SUMMARY

8 This amendment replaces the resolve. The amendment changes the increase in
9 reimbursement for registered nursing, licensed practical nursing and independent registered
10 nursing services from 39% in the resolve to 25%. It also adds an annual cost-of-living
11 adjustment to those rates. It adds rule-making language to the resolve. The amendment
12 also adds an appropriations and allocations section.
