1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 17-A MRSA §1102, sub-§1, ¶O, as enacted by PL 2001, c. 419, §6, is amended to read:
4 5 6	O. Unless listed or described in another schedule, the following hallucinogenic drugs or their salts, isomers and salts of isomers whenever the existence of the salts isomers and salts of isomers is possible within the chemical designation:
7	(1) 3, 4 - methylenedioxy amphetamine, MDA;
8	(2) 5 methoxy - 3, 4 methylenedioxy amphetamine, MMDA;
9	(3) 3, 4, 5 - trimethoxy amphetamine, TMA;
10	(4) 4 - methyl - 2, 5 - dimethoxyamphetamine, DOM;
11	(5) 2, - 3 methylenedioxyamphetamine;
12	(6) 2, 5 - dimethoxyamphetamine, DMA;
13	(7) 4 - bromo - 2, 5 - dimethoxyamphetamine, DOB;
14	(8) 4 methoxyamphetamine;
15	(9) 3, 4 - methylenedioxymethamphetamine, MDMA;
16	(10) 4 - bromo - 2, 5 - dimethoxyphenethylamine, NEXUS;
17	(11) 3, 4 - methylenedioxy-N-ethylamphetamine, MDE;
18	(12) Paramethoxymethamphetamine, PMMA;
19	(13) Paramethoxyamphetamine, PMA; and

29 30	This bill adds to the list of Schedule W drugs certain dangerous synthetic hallucinogenic chemicals that are sometimes marketed as "bath salts."
