SUMMARY 1 2 This amendment replaces the bill. It adds a definition of "cannabis paraphernalia" into 3 the Maine Medical Use of Cannabis Act, Title 22, chapter 558-C, and the Cannabis 4 Legalization Act, Title 28, chapter 1. It clarifies that a person may provide cannabis paraphernalia to a caregiver or registered dispensary for the medical use of cannabis, may 5 be in the vicinity of the medical use of cannabis and is not required to obtain a retail tobacco 6 7 license for this activity. It clarifies that a caregiver, registered dispensary or cannabis store 8 may sell, offer to sell or furnish cannabis paraphernalia for the purpose of cannabis use and 9 that a retail tobacco license is not required for this activity.
