17 18	This chapter may be known and cited as "the Uniform Emergency Volunteer Health Practitioners Act."
19	§949-A. Definitions
20 21	As used in this chapter, unless the context otherwise indicates, the following terms have the following meanings.
22 23 24	<b>1. Disaster relief organization.</b> "Disaster relief organization" means an entity that provides emergency or disaster relief services that include health services or veterinary services provided by volunteer health practitioners as long as the entity:

4. Host entity discretion in selecting volunteers. A host entity is not required to
 use the services of a volunteer health practitioner even if the practitioner is registered
 with a registration system that indicates that the practitioner is licensed and in good
 standing.

- 14 §949-E. Recognition of volunteer health practitioners licensed in other states
- **1. Authority to practice during emergency.** While an emergency declaration is in
   effect, a volunteer health practitioner registered with a registration system that complies
   with section 949-D and licensed and in good standing in the state upon which the
   practitioner's registration is based may practice in this State to the extent authorized by
   this chapter as if the practitioner were licensed in this State.
- 20 2. Disqualification based on professional discipline. A volunteer health
   21 practitioner qualified under subsection 1 is not entitled to the protections of this chapter if
   22 the practitioner is licensed in more than one state and any license of the practitioner is
   23 suspended, revoked or subject to an agency order limiting or restricting practice
   24 privileges or has been voluntarily terminated under threat of sanction.

### 3 §949-H. Relation to other laws

1. Other laws unaffected. This chapter does not limit the rights, privileges or
 immunities provided to volunteer health practitioners by laws other than this chapter.
 Except as otherwise provided in subsection 2, this chapter does not affect requirements
 for the use of health practitioners pursuant to the Emergency Management Assistance
 Compact or the International Emergency Management Assistance Compact.

2. Exceptions; Emergency Management Assistance Compact and International
 Emergency Management Assistance Compact. The Maine Emergency Management
 Agency, pursuant to section 784-A, the Emergency Management Assistance Compact and
 the International Emergency Management Assistance Compact, may incorporate into the
 emergency forces of this State volunteer health practitioners who are not officers or
 employees of this State, a political subdivision of this State or a municipality or other
 local government within this State.

#### 16 §949-I. Regulatory authority

17 The Department of Health and Human Services may adopt rules to implement this 18 chapter. In doing so, the Department of Health and Human Services shall consult with 19 and consider the recommendations of the Maine Emergency Management Agency and 20 shall also consult with and consider rules adopted by similarly empowered agencies in 21 other states to promote uniformity of application of this chapter and make the emergency 22 response systems in the various states reasonably compatible. Rules adopted pursuant to 23 this section are routine technical rules as defined by Title 5, chapter 375, subchapter 2-A.

24 §949-J. Limitations on civil liability for volunteer health practitioners

A volunteer health practitioner who provides health services or veterinary services in
 accordance with this chapter is immune from liability for injury or death arising from the
 provision of those services to the extent provided in Title 24, section 2904.

#### 28 §949-K. Uniformity of application and construction

In applying and construing this uniform act, consideration must be given to the need
 to promote uniformity of the law with respect to its subject matter among states that enact
 it.'

**SUMMARY** 

This amendment strikes and replaces the bill, which is a concept draft, and adopts selected provisions of the Uniform Emergency Volunteer Health Practitioners Act. This amendment does the following.

It defines "volunteer health practitioner" as an individual who provides health
 services or veterinary services, whether or not the individual receives compensation, as
 long as the individual is not providing services in this State as part of a preexisting
 employment relationship. "Volunteer health practitioner" also includes individuals who

are not state residents who provide health services or veterinary services in this State
 while employed by a disaster relief organization.

2. It provides for advanced registration of volunteer health practitioners from this State or other states who agree to provide health services or veterinary services during a civil emergency or health emergency in this State declared by the Governor or the Department of Health and Human Services. Registration systems must determine whether registrants are licensed to provide health services or veterinary services and are in good standing with the relevant licensing entities in this State and other states.

9 3. It authorizes volunteer health practitioners licensed in other states to provide health services and veterinary services in this State during a declared civil emergency or public 10 health emergency. While an emergency declaration is in effect, the Department of Health 11 and Human Services, in coordination with the Department of Defense, Veterans and 12 Emergency Management, Maine Emergency Management Agency, may limit the 13 duration and geographical areas in which a volunteer health practitioner may practice as 14 well as types of volunteer health practitioners who are authorized to provide health 15 16 services or veterinary services.

4. It requires a volunteer health practitioner to comply with both the scope of practice
laws in this State and the scope of practice laws in the state where the individual is
licensed while providing health services or veterinary services in this State during a
declared emergency. The Governor or the Governor's designee may by order modify or
restrict the health services or veterinary services that a volunteer health practitioner may
provide during a declared emergency.

5. It subjects a volunteer health practitioner to discipline by the appropriate state licensing board for health services or veterinary services provided in this State during a declared emergency. An individual who is licensed in Maine and who provides health services or veterinary services during a declared emergency in another state as a volunteer health practitioner is also subject to discipline by the appropriate state licensing board.

6. It protects a volunteer health practitioner from civil liability for injury or death arising out of the provision of health services or veterinary services in accordance with the requirements of the uniform act to the same extent that a health care practitioner in this State is protected from civil liability for volunteer activities under the Maine Health Security Act.

7. It authorizes the Department of Health and Human Services to adopt rules to
 implement the uniform act in consultation with the Maine Emergency Management
 Agency and rule-making agencies in other states that have adopted similar legislation.
