RESOLUTION, Proposing an Amendment to the Constitution of Maine To Implement Ranked-choice Voting

Resolved:** Two thirds of each branch of the 2 Legislature concurring, that the following amendment to the Constitution of Maine be 3 proposed:

Constitution, Art. IV, Pt. First, §5 is amended to read:

5 Section 5. Election of Representatives; lists of votes delivered forthwith; 6 lists of votes examined by Governor; summons of persons who appear to be elected; lists shall be laid before the House. The meetings within this State for the 7 8 choice of Representatives shall be warned in due course of law by gualified officials of the several towns and cities 7 days at least before the election, and the election officials of 9 10 the various towns and cities shall preside impartially at such meetings, receive the votes of all the qualified electors, sort, count and declare them in open meeting; and a list of the 11 persons voted for shall be formed, with the number of votes for each person against that 12 13 person's name. Cities and towns belonging to any Representative District shall hold their meetings at the same time in the respective cities and towns; and such meetings shall be 14 notified, held and regulated, the votes received, sorted, counted and declared in the same 15 manner. Fair copies of the lists of votes shall be attested by the municipal officers and 16 the clerks of the cities and towns and the city and town clerks respectively shall cause the 17 same to be delivered into the office of the Secretary of State forthwith. The Governor 18 shall examine the returned copies of such lists and 7 days before the first Wednesday of 19 December biennially, shall issue a summons to such persons as shall appear to have been 20 elected by a plurality majority of all votes returned, to attend and take their seats. All 21 such lists shall be laid before the House of Representatives on the first Wednesday of 22 December biennially, and they shall finally determine who are elected. 23

24 **Constitution, Art. IV, Pt. Second, §§4 and 5** are amended to read:

Section 4. Lists of votes examined by Governor; summons to persons who appear to be elected. The Governor shall, as soon as may be, examine the copies of such lists, and at least 7 days before the said first Wednesday of December, issue a summons to such persons, as shall appear to be elected by a plurality majority of the votes in each senatorial district, to attend that day and take their seats.

30 Section 5. Determination of Senators elected; procedure for filling The Senate shall, on said first Wednesday of December, biennially 31 vacancies. determine who is elected by a plurality majority of votes to be Senator in each district. 32 All vacancies in the Senate arising from death, resignation, removal from the State or like 33 causes, and also vacancies, if any, which may occur because of the failure of any district 34 35 to elect by a plurality majority of votes the Senator to which said district shall be entitled shall be filled by an immediate election in the unrepresented district. The Governor shall 36 issue a proclamation therefor and therein fix the time of such election. 37

38 **Constitution, Art. V, Pt. First, §3** is amended to read:

Section 3. Election; votes to be returned to Secretary of State; Secretary
 of State to lay lists before the Senate and House of Representatives; provision

1 in case of tie. The meetings for election of Governor shall be notified, held and regulated and votes shall be received, sorted, counted and declared and recorded, in the 2 same manner as those for Senators and Representatives. Copies of lists of votes shall be 3 sealed and returned to the secretary's office in the same manner and at the same time as 4 5 those for Senators. The Secretary of State for the time being shall, on the first Wednesday after the first Tuesday of January then next, lay the lists returned to the 6 secretary's office before the Senate and House of Representatives to be by them 7 examined, together with the ballots cast if they so elect, and they shall determine the 8 number of votes duly cast for the office of Governor, and in case of a choice by plurality 9 majority of all of the votes returned they shall declare and publish the same. If there shall 10 be a tie between the 2 persons having the largest number of votes for Governor, the 11 House of Representatives and the Senate meeting in joint session, and each member of 12 said bodies having a single vote, shall elect one of said 2 persons having so received an 13 equal number of votes and the person so elected by the Senate and House of 14 Representatives shall be declared the Governor. 15

16 **Constitutional referendum procedure; form of question; effective date.** 17 **Resolved:** That the municipal officers of this State shall notify the inhabitants of their 18 respective cities, towns and plantations to meet, in the manner prescribed by law for 19 holding a statewide election, at a statewide election held in the month of November 20 following the passage of this resolution, to vote upon the ratification of the amendment 21 proposed in this resolution by voting upon the following question:

"Do you favor amending the Constitution of Maine to require candidates
for the political offices of Governor, State Senator and State
Representative to be elected by a majority of the votes cast for that
office?"

26 The legal voters of each city, town and plantation shall vote by ballot on this question and designate their choice by a cross or check mark placed within the corresponding 27 square below the word "Yes" or "No." The ballots must be received, sorted, counted and 28 declared in open ward, town and plantation meetings and returns made to the Secretary of 29 30 State in the same manner as votes for members of the Legislature. The Governor shall review the returns. If it appears that a majority of the legal votes are cast in favor of the 31 amendment, the Governor shall proclaim that fact without delay and the amendment 32 becomes part of the Constitution of Maine on the date of the proclamation. 33

Secretary of State shall prepare ballots. Resolved: That the Secretary of State
 shall prepare and furnish to each city, town and plantation all ballots, returns and copies
 of this resolution necessary to carry out the purposes of this referendum.
