**Resolve, To Establish the Committee To Study the Feasibility of
Creating Basic Income Security**

1 **Sec. 1. Committee established. Resolved:** That the Committee To Study the
2 Feasibility of Creating Basic Income Security, referred to in this resolve as "the
3 committee," is established.

4 **Sec. 2. Committee membership. Resolved:** That the committee consists of 13
5 members appointed as follows:

6 1. Four members of the Senate appointed by the President of the Senate, including a
7 representative of each of the following joint standing committees:

8 A. The Joint Standing Committee on Labor and Housing;

9 B. The Joint Standing Committee on Health and Human Services;

10 C. The Joint Standing Committee on Taxation; and

11 D. The Joint Standing Committee on Innovation, Development, Economic
12 Advancement and Business;

13 2. Four members of the House of Representatives appointed by the Speaker of the
14 House, including a representative of each of the following joint standing committees:

15 A. The Joint Standing Committee on Labor and Housing;

16 B. The Joint Standing Committee on Health and Human Services;

17 C. The Joint Standing Committee on Taxation; and

18 D. The Joint Standing Committee on Innovation, Development, Economic
19 Advancement and Business;

20 3. One member of the public who represents low-wage workers and recipients of
21 public benefits, appointed by the President of the Senate;

22 4. One member of the public who represents business and industry, appointed by the
23 Speaker of the House;

24 5. One member who represents the Governor's office of innovation and the future,
25 appointed by the Governor;

26 6. One member who represents higher education, appointed by the Governor; and

27 7. One member who represents a trade union, appointed by the Governor.

28 **Sec. 3. Chairs. Resolved:** That the first-named Senate member is the Senate
29 chair and the first-named House of Representatives member is the House chair of the
30 committee.

31 **Sec. 4. Appointments; convening of committee. Resolved:** That all
32 appointments must be made no later than 30 days following the effective date of this
33 resolve. The appointing authorities shall notify the Executive Director of the Legislative
34 Council once all appointments have been completed. After appointment of all members,
35 the chairs shall call and convene the first meeting of the committee. If 30 days or more

1 after the effective date of this resolve a majority of but not all appointments have been
2 made, the chairs may request authority and the Legislative Council may grant authority
3 for the committee to meet and conduct its business.

4 **Sec. 5. Duties. Resolved:** That the committee shall examine and make
5 recommendations on the feasibility of providing basic economic security through a direct
6 cash payment system and other programs that are designed to help individuals and
7 families become more economically secure, including, but not limited to:

8 1. Tax rebates and credits, including strengthening the earned income tax credit and
9 a negative income tax;

10 2. Universal basic income and unconditional cash transfers to residents of the State;
11 and

12 3. Other direct cash benefit programs.

13 The committee shall also investigate the effectiveness of existing safety net
14 programs, such as tax credit, child care and food supplement programs, and compare
15 those programs to any recommended direct cash payment programs.

16 **Sec. 6. Staff assistance. Resolved:** That the Legislative Council shall provide
17 necessary staffing services to the committee, except that Legislative Council staff support
18 is not authorized when the Legislature is in regular or special session.

19 **Sec. 7. Report. Resolved:** That, notwithstanding Joint Rule 353, no later than
20 February 1, 2020, the committee shall submit a report that includes its findings and
21 recommendations, including suggested legislation, for presentation to the Second Regular
22 Session of the 129th Legislature.

23 **Sec. 8. Outside funding. Resolved:** That the committee shall seek funding
24 contributions to fully fund the costs of the study. All funding is subject to approval by
25 the Legislative Council in accordance with its policies. If sufficient contributions to fund
26 the study have not been received within 30 days after the effective date of this resolve, no
27 meetings are authorized and no expenses of any kind may be incurred or reimbursed.

28 SUMMARY

29 This resolve establishes the Committee To Study the Feasibility of Creating Basic
30 Income Security to examine options to better provide basic economic security to Maine
31 people, including through the development of a direct cash payment system.
