COMMITTEE AMENDMENT “ ” to S.P. 412, L.D. 1324, “Resolve, To Establish the Committee To Study the Feasibility of Creating Basic Income Security”

Amend the resolve in section 2 in the first line (page 1, line 4 in L.D.) by striking out the following: "13" and inserting the following: '11'

Amend the resolve in section 2 in subsection 1 in the first line (page 1, line 6 in L.D.) by striking out the following: "Four" and inserting the following: 'Three'

Amend the resolve in section 2 in subsection 1 in paragraph B (page 1, line 9 in L.D.) by inserting after the following: "Services;" the following: 'and'

Amend the resolve in section 2 in subsection 1 in paragraph C (page 1, line 10 in L.D.) by striking out the following: "and"

Amend the resolve in section 2 in subsection 1 by striking out all of paragraph D (page 1, lines 11 and 12 in L.D.)

Amend the resolve in section 2 in subsection 2 in the first line (page 1, line 13 in L.D.) by striking out the following: "Four" and inserting the following: 'Three'

Amend the resolve in section 2 in subsection 2 in paragraph B (page 1, line 16 in L.D.) by inserting after the following: "Services;" the following: 'and'

Amend the resolve in section 2 in subsection 2 by striking out all of paragraph C (page 1, line 17 in L.D.)

Amend the resolve in section 2 in subsection 2 in paragraph D in the first line (page 1, line 18 in L.D.) by striking out the following: "D." and inserting the following: 'C.'

Amend the resolve in section 2 in subsection 3 in the first line (page 1, line 20 in L.D.) by striking out the following: "One member of the public who represents" and inserting the following: 'Two members of the public who represent'

Amend the resolve in section 2 by striking out all of subsection 5 (page 1, lines 24 and 25 in L.D.)

**COMMITTEE AMENDMENT**

1 Amend the resolve in section 2 in subsection 6 in the first line (page 1, line 26 in  
2 L.D.) by striking out the following: "Governor" and inserting the following: 'Speaker of  
3 the House'

4 Amend the resolve in section 2 by renumbering the subsections to read consecutively.

5 Amend the resolve in section 5 by inserting at the end a new indented paragraph to  
6 read:

7 'In fulfilling its duties under this section, the committee shall as necessary invite input  
8 from the Department of Administrative and Financial Services, Bureau of Revenue  
9 Services and from the Governor's Office of Policy and Management.'

10 Amend the resolve by striking out all of section 7 and inserting the following:

11 '**Sec. 7. Report. Resolved:** That, no later than November 4, 2020, the committee  
12 shall submit a report that includes its findings and recommendations, including suggested  
13 legislation, for presentation to the First Regular Session of the 130th Legislature.'

14 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or  
15 section number to read consecutively.

#### 16 SUMMARY

17 This amendment, which is the majority report of the committee, amends the resolve,  
18 which establishes the Committee To Study the Feasibility of Creating Basic Income  
19 Security, as follows.

20 1. It changes the membership of the committee.

21 2. It requires that the committee in fulfilling its duties invite input as necessary from  
22 the Department of Administrative and Financial Services, Bureau of Revenue Services  
23 and from the Governor's Office of Policy and Management.

24 3. It changes the date of the committee's report to the Legislature.
