In view of the emergency cited in the preamble, this legislation takes effect when approved.' 18 19 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively. 20 SUMMARY 21 22 This amendment adds provisions that allow a limited electrician to supervise licensed helper and apprentice electricians to the same extent as under current law and that allow 23 24 applicants for a master electrician license to count hours worked as an apprentice 25 electrician toward the 12,000-hour experience requirement, as is permitted in current law. 26 This amendment also makes technical changes to the bill and adds an emergency 27 preamble and emergency clause.
