"Private natural gas pipeline" means a pipeline that is used solely for the transport of natural gas to a single customer and is owned by the customer and whose owner or operator is not otherwise regulated by the commission as a natural gas pipeline utility or gas utility. For purposes of this paragraph, "customer" includes an affiliate of a customer.
26 27	<b>Sec. 2. 35-A MRSA §4517, sub-§§2 and 3,</b> as enacted by PL 2011, c. 110, §1, are amended to read:

Safety regulation.</b> The commission may exercise safety regulation over an entity that owns or operates a private natural gas pipeline on public land or land owned by a 3rd party, notwithstanding that the entity is not a public utility. <u>The commission may exercise safety regulation over the owner or operator of an affiliated compression or liquefaction facility, notwithstanding that the owner or operator is not a public utility. Safety regulation under this subsection may be enforced as provided in sections 4515 and 4516-A.</u>

## **COMMITTEE AMENDMENT**

1 Approval of construction. A private natural gas pipeline or affiliated 3. 2 compression or liquefaction facility may not be constructed without approval of the 3 commission. When requesting approval, the entity that owns or operates a private natural gas pipeline or affiliated compression or liquefaction facility shall submit to the 4 commission information concerning the engineering design of the pipeline or affiliated 5 6 compression or liquefaction facility and the standards of construction the entity proposes to follow and any other information the commission determines necessary to make a 7 8 determination of whether to approve construction. The commission shall approve the 9 construction if the commission determines that the standards of construction of the 10 pipeline or affiliated compression or liquefaction facility adequately protect the safety of 11 the public.

## Sec. 3. 35-A MRSA §4517, sub-§5 is enacted to read:

13 5. Sale by affiliate of liquefied natural gas or compressed natural gas. The owner or operator of a private natural gas pipeline that delivers natural gas to its affiliate 14 that then liquefies or compresses the natural gas for sale or distribution to others by 15 means other than by a pipeline is not, as a result of the delivery, considered a public 16 utility. The owner or operator of an affiliated compression or liquefaction facility is not 17 18 considered a public utility if the owner or operator is not otherwise regulated by the 19 commission as a public utility.'

## SUMMARY

21 This amendment clarifies that the Public Utilities Commission has safety jurisdiction 22 over facilities that are used to liquefy or compress natural gas for sale or distribution to 23 others by means other than a pipeline and that are owned or operated by an affiliate of the 24 owner of a private natural gas pipeline.
