Testimony of Jonathan Wayne, Executive Director of the Commission on Governmental Ethics and Election Practices before the Joint Standing Committee on Veterans and Legal Affairs February 14, 2018

Senator Mason and Representative Luchini, distinguished members of the committee: my name is Jonathan Wayne, and I am the Executive Director of the Maine Ethics Commission. Thank you for the opportunity to testify in support of LD 1780, which is an agency bill to request one-time additional revenue of \$700,000 to the Maine Clean Election Fund to minimize the risk of a shortfall in the Fund midway through the 2018 election year. (The bill was originally drafted in December 2017 to request a larger amount, which we have reduced in light of additional information now available.)

Under current law, the Commission is obligated to pay both legislative and gubernatorial candidates who successfully qualify for Maine Clean Election Act (MCEA) funding. Payments to MCEA candidates are made from a single account, the Maine Clean Election Fund.

If the Legislature wishes to minimize the risk of a shortfall during this year's elections, the Commission staff suggests having sufficient funding for three gubernatorial candidates for the primary election and two gubernatorial candidates in the general election (shown as scenario B on page 3 of this handout). In this scenario, we estimate that the Maine Clean Election Fund would need a one-time transfer of \$700,000 to avoid running out of money. If fewer candidates for Governor qualify for funding for the 2018 primary and general elections, no shortfall will occur.

 $^{^1}$ In order to qualify for MCEA funding, candidates for Governor must qualify for the ballot and collect 3,200 qualifying contributions by April 2^{nd} . This is going to be difficult for most of the gubernatorial candidates who have declared an interest in qualifying for this funding.

Effects of a shortfall. In scenario B, the Commission staff estimates that the shortfall could be in the range of \$400,000 - \$700,000, but it would depend on how many legislative candidates are in the program and to what extent candidates qualify for supplemental payments based on collecting additional qualifying contributions. Any shortfall would cause alarm for both legislative and gubernatorial candidates, and would shake confidence in the program.

Nevertheless, the candidates could still receive most of the public funds for which they could qualify (probably in the range of 90%). To make up for the reduced payment amounts, the Commission could authorize candidates to collect traditional campaign contributions. There are various ways to structure this, and the final decision would be made by the Commissioners after receiving input, and with as much advance notice to candidates as is practical so that they could plan ahead.

For members who are new to the State's management of the Maine Clean Election Fund, I have attached a history of deappropriations from the Fund and revenue that the Legislature has provided to replenish the Fund when necessary.
