Amend the amendment in section 2 in the 2nd line (page 1, line 14 in amendment) by striking out the following: "13" and inserting the following: '17'

Amend the amendment in section 2 in subsection 1 in paragraph A in the first line (page 1, line 16 in amendment) by striking out the following: "Two" and inserting the following: 'Three'

Amend the amendment in section 2 in subsection 1 in paragraph C in the last line (page 1, line 22 in amendment) by striking out the following: "and"

Amend the amendment in section 2 in subsection 1 by inserting after paragraph D the following:

‘Sec.

E. One representative of the Maine chapter of the American Academy of Pediatrics; and’

Amend the amendment in section 2 in subsection 2 in paragraph A in the first line (page 1, line 26 in amendment) by striking out the following: "Five" and inserting the following: 'Six'

Amend the amendment in section 2 in subsection 2 in paragraph C in the last line (page 1, line 33 in amendment) by striking out the following: "designee; and" and inserting the following: 'designee;'

Amend the amendment in section 2 in subsection 2 in paragraph D in the first and 2nd lines (page 2, lines 1 and 2 in amendment) by striking out the following: "be it further"

Amend the amendment in section 2 in subsection 2 by inserting after paragraph D the following:

‘Sec.

E. One representative of the Maine Society of Otolaryngology; and be it further’

Amend the amendment by striking out all of section 9 and inserting the following:
